The reporting person may be deemed to beneficially own the shares of common stock owned by the Trust.
- The option was granted on January 5, 2018. The shares underlying the option vest over four years, with 25% of the shares vested on January 5, 2019 and the remaining shares vesting in equal quarterly installments thereafter.
- The option was granted on April 2, 2018. The shares underlying the option vest over four years, with 25% of the shares vested on April 2, 2019 and the remaining shares vesting in equal quarterly installments thereafter.
- The option was granted on March 5, 2020. The shares underlying the option vest in full upon the date on which the Board of Directors of the Issuer determines that the Issuer has dosed the initial patient in its first clinical trial, provided that such event occurs on or before July 1, 2023.
- The option was granted on March 5, 2020. The shares underlying the option vest over four years, with 25% of the shares vesting on March 5, 2021 and the remaining shares vesting in equal quarterly installments thereafter.
